Successful PRPA Trip with ex-SP&S 700 becomes Memorial Trip for Don Wheeler

As announced in previous editions of the Trainmaster, the Pacific Railroad Preservation Association has been planning for some time to operate the es-SP&S #700, one of the steam locomotives operated by the city of Portland, into Montana for excursion service for the Montana Daylight group. Early in the trip, the group found out that its president, Don Wheeler, had passed away. As it is fairly newsworthy every time one of these steam locomotives gets out and runs, and since the PRPA and the Chapter participated in several joint excursions during Don's administration as president of the PRPA, we thought chapter members should see this article:

A Trip - In Memoriam, By Jim Vanderbeck, Acting President of the Pacific Railroad Preservation Association

After all the endless hours of work had finally come together for the SP&S 700 to head to Montana, the PRPA was hit with terrible news that Don Wheeler, the President of PRPA, had passed away at about the exact time the engine was pulling out of Vancouver for its journey east. The 700 was heading down the mainline because of Don Wheeler.

Only a few years ago the 700 was stuck in the Brooklyn roundhouse with nowhere to go and nothing in the future. Don, with the skill and experience of a union mediator, worked with Walt Eisenman to hold the PRPA together. Don started to open some doors to the future. Little things at first There were talks with the PNWC-NRHS and their president George Hickok Don and George had visions of what the PRPA could do with the 700. Don set goals of operations but also of community involvement promoting the historical significance of the 700 steam engine and the Brooklyn area. The PRPA, under Don's guidance, participated in fund raising for OPB Operation Lifesaver-the safety program of the railroads, and encouraged the railroad community to use the 700 as a promotional tool. We had our milestones and our setbacks. Don guided us on. Regretfully, as PRPA go stronger, Don was getting noticeably weaker. He never let on until the last how much pain he was in.

Early this year, Don turned the presidency over to me. Staggering a bit at first, the crew came together as never before. We dedicated this trip to Don. At 2:00 PM Mountain time on October 14. 2002, the same time as the funeral in Vancouver, the entire crew stopped servicing the locomotive in Collectors Association and Toy Train Columbus Montana and gathered in front of the 700. I led a salute to Don Wheeler followed by a long blast of the whistle.

We knew Don was with us.

PNWC/NRHS General Meeting Minutes November 15, 2002

CTO: 7:36 p.m. by President Arlen Sheldrake
Pledge of Allegiance: Arlen led the Chapter in the pledge
of allegiance to the flag.

Welcome members and guests: Guest John Bergner Officer's Reports:

Secretary: Judy Hall

There were no additions or corrections to the October minutes as printed in the Trainmaster. Kerrigan Gray moved and Jim Long seconded that the minutes be approved. The motion passed.

Treasurer: Rick Banton reported that due to the POTB excursion and generous recent donations by members, the Chapter. (Any member who would like to view the Treasurer's report may do so at Room 1, Union Station.)

President: Arlen Sheldrake reported on the Board of Directors meeting. The Board has adopted an "Acceptable Use Policy" for the Mt. Hood car. This gives the Chapter leasing agent guidelines for leasing the car. This is the Chapter's most valuable car and in mostly original condition. Copies of the policy have been sent to other railroad groups. The Jack Holst Award committee will consist of Maxine Rodabaugh, George Hickok and Gerald Schuler.

- "Peggy" Shay locomotive: The World Forestry Center is cosmetically fixing her up (budget, \$50,000), moving the locomotive out to the front of the building and constructing a shelter over her (budget, \$200,000). Glen Gilbert from the WFC would like anyone who has an interest in "Peggy" to help out with an interpretive display that he is working on and give advice on the restoration.
- December Meeting Potluck: There will be a potluck dinner for the December meeting in addition to the election. Darel Mack has volunteered to head up the potluck and requested that members bring their favorite salad, hot dish or dessert. It will start at 6:00 pm.
- Chapter Banquet: The banquet will take place in March. Judy Hall volunteered to set a date with

Saylers in Beaverton where the banquet was held last year. The date has not been verified yet.

New NW Regional Vice-president: Arlen congratulated Gerald Schuler for his election to the regional vice-presidency for the remainder of 2002 and for 2003. Gerald said he will try to follow in the footsteps of Rich Carlson (deceased).

National Board of Directors Meeting in Mt. Pleasant, IA: Arlen, Gerald & Olive Schuler rode Amtrak to Mt. Pleasant. They presented the PNWC Chapter's bid for the 2005 NRHS National Convention. The Board accepted the bid. The Williams, AZ chapter offered their congratulations. They hosted this year's convention. Gerald urges all members to mail their pre-registration money in for the 2003 convention in Baltimore hosted by the Washington, D.C. Chapter. Pre-registration is \$35 until Jan. 31 and then it goes up to \$45.

2005 Convention Planning Committee: The planning committee will be meeting Dec. 14 from 1:00 pm to 4:00 pm at the Double Tree, Lloyd Center. Arlen said he has received excellent assistance from Portland Oregon Visitors Assoc. and from Carl Jensen, National Convention Chairman.

Portland Union Station Annex re-roofing: The station has received the funding it needs to re-roof the annex and tie it to the building to meet seismic requirements. The \$400,000 needed for the project will come from Capital Project Funds and take about 3 years to complete. The roofing tiles are metal and of a unique design. The Chapter's offices, library and archive are located in the annex.

Committees Reporting:

<u>Elections Committee:</u> Darel Mack thanked everyone who is running for office for volunteering to run.

<u>Membership:</u> Maxine Rodabaugh said there were 240 paid-up members and 51 family members for a total of 291 members. Renewals have not been received from National.

Excursions: Al Hall said it may be difficult to host excursions in 2003 due to the tremendous increase of insurance prices. In the past the P&W railroad wanted \$1 million in coverage, then \$5 mil. and most recently \$10 mil. Now they want \$50 mil. in coverage. The cost of insurance has gone from \$1,000-1,500 per million dollars of coverage to \$2,500 -\$3,500 per million. There is some doubt if the Chapter will be able to operate any excursions on the P&W railroad. Al said there will be a Rail Summit at Antique Powerland on Saturday, Nov. 16.

Rolling Stock: Arlen reported that the 6200 will be operating over the POTB railroad tomorrow for a fourth day of lease. Part of this lease arrangement is another cost free pull from the POTB within the next 18 months. George Hickok has been taking care of the 6200 during the four lease days to make sure everything on the car operates properly. Al Hall said George has been doing an outstanding job; out at Tillamook in the early-mornings to heat the car and staying late at night cleaning it up for the next trip.

• The Twin Grove has departed Portland for Avery, ID. Thank you to Mildred Messmer who provided the funds to move the car. The Chapter had been paying the P&W, \$10 per day for storage on their track. The car should arrive in Plummer, ID about Nov. 18 and then it will be trucked to Avery. The Twin Grove will be put on static display in downtown Avery.

Library:

• Lending Library: Judy Hall reported that Irv Ewing is out of town and the library meeting for Sat. Nov. 16 is canceled but the library will be open from 1:30 pm until 4:00 pm and Ted & Cora Ahlberg will be the librarians. Ralph Johnson said the library meeting is scheduled for 9:00 am on Sat., Nov. 23. John Willworth has brought books and videos for members to check out.

For the Good of the Order: Arlen reported that the P&W leased the BNSF tracks from Quinaby to Eugene. The Baldwin Steamengine #2507 is going to Wishram, WA. It formerly resided at Maryhill before being moved to Pasco.

- Arlen sent the editor of Trains Magazine a thank you for the great article about Portland in the December issue. It was very timely considering that the Chapter was selected to host the 2005 NRHS Convention about the same time that the magazine hit homes and newsstands.
- Ted Ahlberg said the Chapter will have a table at the SP&S Swap meet on Feb. 1, 2003
- Bob McCoy rode the "Montana By Steam" trip with the SP&S 700 last month. He rode in the Great Northern dome car and said it was a wonderful trip.

- Ron McCoy brought an 8x10 photo of Gerald Schuler that was published in the Annual NRHS Bulletin. In case you didn't notice, it was the largest photo of any chapter. Thanks Ron!
- Leonard Morgan suggested that a by-state directory be added to the Bulletin. Now chapters are listed alphabetically and it is difficult to locate chapters by state.

<u>Tonight's Meeting Program:</u> Bill Thomasson has assembled some old, silent, black & white, 8 mm film and put it on video for the enjoyment of those attending the meeting.

Motion to adjourn: Adjourned at 8:25. Chapter members enjoyed refreshments provided by Cora and Ted Ahlberg.
